

## 2025 National Cattle Congress Queen Contest Information



**Purpose:** The purpose of the National Cattle Congress Queen is to give young women an opportunity to display their citizenship and professionalism by representing the National Cattle Congress Fair as an ambassador and to shine a positive light on the organization. In addition, the queen represents the fair at the Iowa State Fair Queen Contest in August at the beginning of that fair. The Iowa State Fair Queen is a high-profile ambassador of one of Iowa's most significant annual events, and the competition offers scholarships to several contestants that compete at a high level.

### **Qualifications:**

- 16-21 years old as of August 7, 2025
- Must be an Iowa resident – due to the scope of participation in the National Cattle Congress Fair, contestants are not limited to Black Hawk County or contiguous counties
- Must be an active member of at least one service organization in the contestant's community (e.g., Girl Scouts, church group, 4-H, FFA) – not limited to 4-H or FFA involvement
- Must not be a professional model (ongoing employment in which modeling is the primary part of the job)
- Must have never been married and will not be married before July 2026 when the queen relinquishes her crown
- Must not be a past competitor in the Iowa State Fair Queen Contest

## 2025 National Cattle Congress Queen Contest Information

### Attire:

- Arrive in casual attire so contestants are comfortable and do not wrinkle or soil their competition clothing while traveling.
- Formal Gown – At least one portion of the hemline must be floor length (touching the floor or the contestant's foot). If a gown has skirt split more than 2 inches above the knee, a low-cut bodice and/or cut/design inappropriate for the pageant, it may be discounted by the judges.
- Interview Attire – During the initial competition activities, contestants need to wear a business-appropriate dress (with a jacket or sweater if desired), jacket/skirt/pants, or a one-piece outfit.

### Additional Information:

- Parents, guardians and others accompanying the queen candidates must leave Electric Park during the contest. However, they are welcome to return shortly before coronation to be present for that portion of the event.
- Judges will interact and observe contestants outside the interview and formal gown judging (except during private time for wardrobe changes, etc.).
- The 2025 Queen will have experienced local assistants (including past NCC Fair Queens) help them prepare for the Iowa State Fair Queen Contest in August.
- The National Cattle Congress Queen is required to participate at the National Cattle Congress Fair September 17-21, 2025, including but not limited to opening night events (Wednesday); open dairy show (Friday); youth dairy show, and foods judging (Saturday).
- The National Cattle Congress Queen will attend and participate in the Friends of NCC Barn Bash the evening of Saturday, August 23, 2025, and the 2026 National Cattle Congress Queen Contest in June or July 2026.
- The National Cattle Congress Queen may be asked to represent the National Cattle Congress Fair in the My Waterloo Days, Sturgis Falls, and possibly other area parade events.
- The National Cattle Congress Queen must act respectfully and dress appropriately at all times, including when not officially representing the organization. The queen may be required to relinquish her crown and title if it is determined that any conduct does not reflect positively on herself, her family, and/or the National Cattle Congress Fair.
- At the end of the queen's successful reign, she will be awarded \$100 following the coronation of the next queen.
